

PROFESSIONAL INDEMNITY INSURANCE - INTERNATIONAL COVER **GENERAL INFORMATION**

The Sports Therapists Association of Hong Kong (STAoHK) serves as a regulatory and professional body for sports therapists (ST) practicing or ST students enrolled in accredited programs (or equivalent professional qualifications) both in Hong Kong and overseas.

Recognizing the trend of sports therapists and related professionals practicing outside of the HKSAR, STAoHK now offers Professional Indemnity (PI) insurance that extends overseas. This insurance is available to both categories of members, relating to the Scope of Practice (SoP) published by STAoHK.

WHO WILL BE SUITABLE?

International cover is the best for those members who are employed/contracted outside the HKSAR jurisdiction. Overseas contracts that cover under HKSAR jurisdiction are **not required** for an international cover. Typical example is an employee who asked for overseas team duty and the contract is bound to HKSAR jurisdiction.

INTERNATIONAL COVERS

Category A members and Category B members with PI insurance can apply for an upgrade of the coverage overseas by **VOLUNTARY**. The coverage breakdowns are as follows (inclusive of Government levy):

- Asia-Pacific area

HKD \$863.36/year (HKD\$112.61/year for covered members)

- Worldwide (excluding USA and Canada)

HKD \$976.47/year (HKD\$216.72/year for covered members)

HOW TO APPLY

Members should download and complete the **change form** from the Association's website and send the completed change form along with required documents to enquiry@staohk.org :

The commencement date will be set on 1 July(annual) or 1 Jan(semi-annual), and the coverage period will be valid until June 30, 2025.

APPLICATION PERIOD

International coverage can be added throughout the policy period. Premium will be calculated in annual or semi-annual and commencement date will be set on 1 July or 1 Jan only. **No pro-rata premium will be provided.**

EXPIRED MEMBERSHIP

Expired membership can apply for revival within one month of expiry, **with or without** a request for international cover, **plus administration fee \$200**. We are unable to proceed with any revival requests that expired over one month. Applicants must wait till the next application batch with an administration fee imposed.
